**All Instruments will be Paid for and picked up at Shop at the beginning of rental. The first two months include a free maintenance trial period. Subsequent payment will be by autodraft on the first of the month. 1st month can be prorated.**

### Rental/Maintenance Agreement

Instruments will be rented on a monthly basis. Rental payments are made monthly and are due on the 1st of every month. Rental costs can be applied to the purchase of the rental or a new instrument at the rate of 75% of rent paid. Student may trade up for a larger instrument as needed. Renter will be responsible for the full cost of the instrument in the case of loss, neglect, or deliberate destruction. Bases and Cellos will be rented for a minimum of a year. Renter is required to keep all contact and payment info current. Late charges may apply if I cannot reach you in the case of expired cards.

**TERMS AND CONDITIONS** This is a month to month lease. The monthly payments can be used toward the purchase of the instrument. For your convenience we offer auto draft for payments. The monthly rental will be charged automatically to your debit or credit card.

**TITLE AND RIGHT OF POSSESSION** Wm Mason retains title of ownership throughout the rental period. When regular payments equal the agreed purchase price (established at time of rental), title of ownership will be passed to the renter. If the Renter is more than 30 days late in payment, unless cleared by Wm Mason II Violin Shop, the Renter authorizes us to charge the credit card given at the time of rental for payment of any overdue amount.

**RETURN PROCEDURES** The instrument may be returned at any time during the rental period, excluding cello and bass during the 1st year.

**MAINTENANCE** Maintenance is required on all instruments. All maintenance and repair **MUST** be made by Wm Mason II Violin Shop. **COVERAGE IS VOID IF THE ACCOUNT BECOMES DELINQUENT.** We reserve the right to cancel the agreement if there is constant abuse to an instrument inconsistent with normal use. Renter will be responsible for the full cost of the instrument in the case of loss, neglect, or deliberate destruction.

**EXCHANGES** The instrument covered by this rental agreement may be exchanged for any other instrument during the rental term, based upon the Renters account being current. When applicable any difference in price categories between instruments will be reflected in the rental agreement.
